Details & Schedule for Vacant Seats admission process in Government/GIA and Govt. Autonomous institutes

For vacant seats in Govt./Grant-In-Aid and Govt. autonomous institutes, an online round for these vacant seats is to be conducted as per following details and schedule in line with prevailing rule 20 (1) (i). The vacant seats details are displayed on committee's website

After offering vacant seats to candidates who are in merit of ACPC as per above procedure and timeline, the vacant seats arising due to non-allotment are to be filled as per rule 20 (1) (ii) by inviting applications from candidates who have cleared qualifying exam with minimum eligibility criteria as prescribed in rule 5 for prevailing Govt. notification but have neither qualified GATE nor appeared in Common Entrance Test (PGCET) conducted by ACPC for the corresponding year, giving priority to candidates who are in merit of ACPC. The detailed schedule, available vacant seats and related modalities for such candidates shall be displayed on the committee's website tentatively on 23/09/2022.

Details & Schedule of Vacant seats admission process at Self-Finance (Un-aided) Institutions (SFI)

The Vacant seats in Self Finance (Un-aided) Institutes (SFI) shall be filled as per provisions of rule 20 (2) of prevailing notification of Govt. of Gujarat. Accordingly aspiring candidates fulfilling eligibility criteria of notification for admission to ME/MTech courses dated 30.6.2020 and all its subsequent amendments duly issued by Education department, Government of Gujarat shall have to contact the concerned self-finance institute of his choice between <u>17-09-2022 to 30-09-2022</u> for vacant seats admission process at the institute of his choice and preference. The candidate has to submit his application with all requisite documents and an application fee of Rs. 500/- (Only from those who are not in merit of ACPC) at the concerned institution within the prescribed time limit.

The concerned self-finance institute shall process the filling up of vacant seats among such eligible candidates in accordance with all provisions of prevailing notifications of Government of Gujarat for admission to ME /M. Tech courses. The concerned institute shall prepare common intra-se merit list in the following order and guidelines issued by the Admission Committee from time to time:

(i) the names of the candidates whose name appear in the merit list of the Admission Committee;

(ii) after allotting the seats to candidates mentioned above, if seats remain vacant, the unaided colleges or institutions shall fill such seats from the candidates who have cleared the qualifying examination with minimum eligibility criteria prescribed in rule 5 but have neither qualified in GATE nor appeared in the Common Entrance Test of the corresponding year, conducted by the Admission Committee. The merit list of such candidates shall be prepared based on percentage of marks obtained at qualifying examination.

The vacant seats details and its guidelines and procedure for filling in SFI institutes at institute level are available on committee's website.

In case of admission to SFI in vacant seats at institute level, the process for refund of fee for seat already allotted by this committee shall be as per rule 19 of prevailing notifications of Government-of Gujarat for admission to ME/MTech courses.
