GH/SH/33/2022/PVS/102020/13/S ::- In exercise of the powers conferred by sub-section (1) of section 20 read with section 4 of the of the Gujarat Professional Technical Educational Colleges or Institutions (Regulation of Admission and Fixation of Fees) Act, 2007 (Guj. 2 of 2008), the Government of Gujarat hereby makes the following rules further to amend the Diploma in Engineering courses to Bachelor of Engineering and Technology courses (Regulation of Admission and Payment of Fees) Rules, 2022, namely:-

- 1. (1) These rules may be called the Diploma in Engineering courses to Second year (Third semester) of Bachelor of Engineering and Technology (Regulation of Admission and Payment of Fees) (Amendment) Rules, 2022.
  - (2) They shall come into force on the date of their publication in the official Gazette.
- 2. In the Diploma in Engineering courses to Bachelor of Engineering and Technology courses (Regulation of Admission and Payment of Fees) Rules, 2020, in rule 21 for sub-rule (1), the following sub-rule shall be substituted, namely:
  - "(1) The vacant seats of Government and aided Colleges / Institution shall be filled by Admission Committee through online/offline counseling in the following order, namely:-
    - (i) the names of the candidates whose name appear in the merit list of the Admission Committee:
    - (ii) After allotting the seats to the candidates mentioned in clause (i) above, if seats remain vacant, the Admission Committee shall fill such seats by inviting the application from the candidates who have passed the qualifying examination with minimum aggregate marks as prescribed in rule 6 in immediate previous academic year from the Technical Examination Board (TEB) or a recognised University or college or institution approved by AICTE/UGC and situated in Gujarat State, but the result is declared later by the concern University/Board after the last date of registration as declared by the Admission Committee shall be eligible for admission.

- (iii) After allotting the seats to the candidates mentioned in clauses (i) and (ii) above, if seats remain vacant, the Admission Committee shall fill such seats by inviting the application from the candidates who have passed the qualifying examination with minimum aggregate marks as prescribed in rule 6 in any previous academic year from the Technical Examination Board (TEB) or a recognized University or college or institution approved by AICTE/UGC and situated in Gujarat State, shall be eligible for admission,
- (iv) After allotting the seats to the candidates mentioned in clauses (i), (ii) and (iii) above, if seats remain vacant, the Admission Committee shall fill such seats by inviting the application from the candidate who has passed D.Voc. Stream in the same or allied sector from a recognized University, situated in the Gujarat State. The merit shall be prepared on the basis of theory marks secured in the final year:

Provided that the Universities will offer suitable bridge courses such as Mathematics. Physics. Engineering drawing, etc., for the students coming from diverse backgrounds to achieve desired learning outcomes of the program.

- (v) After allotting the seats to the candidates mentioned in clauses (i), (ii), (iii) and (iv) above, if seats remain vacant, the Admission Committee shall fill such seats by inviting the application from the candidate who has passed the B.Sc Degree examination with Mathematics as one of the subjects in HSC, from a recognized University, situated in the Gujarat State, in any previous academic year shall also be eligible. Merit shall be prepared on the basis of theory marks secured in the subject of Mathematics, Physics and Chemistry in HSC examination. The criteria for deciding merit order in case of students having equal merit marks shall be in the following sequence, namely:-
  - (a) On the basis of theory marks secured in the subject of Mathematics, Physics, Chemistry in HSC examination,
  - (b) Marks obtained in mathematics in HSC Examination.
  - (c) Marks obtained in English in HSC Examination.
  - (d) Total marks obtained in compulsory subjects of the Secondary School

## Certificate Examination (Standard X),

- (e) Date of Birth (Candidate who is older in age shall be given priority)
- (vi) After allotting the seats to the candidates mentioned in clauses (i),(ii), (iii), (iv) and (vi) above, if seats remain vacant, the admission committee shall fill such seats by inviting the application from the candidate eligible as per rule 5 and who has passed the qualifying diploma examination from a recognized University or a college or institution approved by AICTE/UGC, from other States, giving priority to the candidate who are origin of Gujarat".
- (2) for sub-rule (2), the following sub-rule shall be substituted namely:-
  - " (2) After offering admission to all the candidates whose names appear in the merit list or after completion of the online admission process, if unaided college or institution seats remain vacant, such vacant seats shall be filled by the unaided college or institution as per the direction issued by the Admission Committee.

The Admission Committee shall, by an advertisement in the prominent newspapers widely circulated in the State, by web-site and by such other means, as it may consider convenient, display the details of vacant seats and Schedule for vacant seats admission on website. The candidates who are already having the merit number of Admission Committee shall have to submit copy of his registration form to participate for the vacant seats round. Whereas the eligible candidates who have not registered earlier shall have to apply at institute level as per schedule declared by the Admission Committee.

All eligible/meritorious candidates shall have to approach to self-finance institutes of his choice for admission in vacant seats. An acknowledgement shall be given to candidate by concern self finance institutions. The concerned self financed institutions shall process the filling up of vacant seats among such eligible candidates who have submitted registration form by preparing common intra-se merit list in the following order and guidelines issued by the Admission Committee from time to time:

(i) the names of the candidates whose name appears in the merit list of the Admission Committee;

- (ii) After allotting the seats to the candidates mentioned in clause (i) above, if seats remain vacant, the un-aided colleges or institutions shall fill such seats by inviting the application from the candidates who have passed the qualifying examination with minimum aggregate marks as prescribed in rule 6 in immediate previous academic year from the Technical Examination Board (TEB) or a recognised University or college or institution approved by AICTE/UGC and situated in Gujarat State, but the result is declared later by the concerned University/Board after the last date of registration as declared by the Admission Committee shall be eligible for admission.
- (iii) After allotting the seats to the candidates mentioned in clauses (i) and (ii) above, if seats remain vacant, the un-aided colleges or institutions shall fill such seats by inviting the application from the candidates who have passed the qualifying examination with minimum aggregate marks as prescribed in rule 6 in any previous academic year from the Technical Examination Board (TEB) or a recognized University or college or institution approved by AICTE/UGC and situated in the Gujarat State, shall be eligible for admission.
- (iv) After allotting the seats to the candidates mentioned in clauses (i), (ii) and (iii) above, if seats remain vacant, the un-aided colleges or institutions shall fill such seats by inviting the application from the candidates who have passed D.Voc. Stream in the same or allied sector from a recognized University, situated in the Gujarat State. The merit shall be prepared on the basis of theory marks secured in the final year:

Provided that the Universities will offer suitable bridge courses such as Mathematics, Physics, Engineering drawing, etc., for the students coming from diverse backgrounds to achieve desired learning outcomes of the programme.

(v) After allotting the seats to the candidates mentioned in clauses (i),(ii),(iii) and (iv) above, if seats remain vacant, the unaided colleges or institutions shall fill such seats by inviting the application from the candidate who has passed B.Sc Degree examination with Mathematics as one of the subjects in HSC, from a recognized University, situated in the Gujarat State, in the any previous academic year shall also be eligible. Merit shall be prepared on the basis of theory marks secured in the subject

of Mathematics, Physics and Chemistry in HSC examination. The criteria for deciding merit order in case of students having equal merit marks shall be in the following sequence, namely:-

- (a) On the basis of theory marks secured in the subject of Mathematics, Physics, Chemistry in HSC examination,
- (b) Marks obtained in mathematics in HSC Examination.
- (c) Marks obtained in English in HSC Examination.
- (d) Total marks obtained in compulsory subjects of the Secondary School Certificate Examination (Standard X).
- (e) Date of Birth (Candidate who is older in age shall be given priority)
- (vi) After allotting the seats to the candidates mentioned in clauses (i),(ii), (iii),
  - (iv) and (v) above, if seats remain vacant, the unaided colleges or institutions shall fill such seats by inviting the application from the candidate eligible as per rule 5 and who has passed the qualifying diploma examination from a recognized University or a college or institution approved by AICTE/UGC, from other States, giving priority to the candidate who are origin of Gujarat.
