## Subject: Regulations related to foreign students.

In view of the ensuing admissions in Technical and Professional Courses in the Academic Session 2017-18 below mentioned regulations in respect of foreign nationals pursuing higher studies and professional/ technical courses are brought to your notice.

These regulations are required to be circulated among the constituent colleges/ institutions under your jurisdiction. The same may please be uploaded on your website also.

 A foreigner is required to hold a "Student" visa (specified as 'S' visa) for pursuing higher studies and professional/ technical courses in India.

2. Any other type of visa (viz. 'T', 'X', 'E' etc) are not appropriate category for taking admission in higher studies and professional/ technical courses.

3. Foreign nationals holding PIO Card or OCI Card are not required to have "S" Visa for admissions in higher studies and professional/ technical courses. However, other below mentioned regulations are applicable on them also.

4. As per Rule 15 of Foreigners (Amendment) Order, 2016 every University/ Educational Institution is required to submit S-Form within 24 hours of enrollment of a foreign student. The registration for taking User ID for submitting S-Form and online submission of S-Form could be done at <a href="https://www.indianfrro.gov.in/fsis">www.indianfrro.gov.in/fsis</a>

5. The university/ Institute is required to update the academic performance, attendance and general behavior of the foreign student and other required fields in the S-Form Module at the end of each quarter.

6. In case of change of institute/ course and completion of course the university/ institute is required to fill the transfer details and exit details respectively in the S-Form module.

 The foreigner holding Student visa are to be given admission in NRI/ Management seats only.

To be given admission on their specified seats.

The university/ institute is required to provide a 'Bonafied Certificate' in the prescribed Performa to the student for registration at FRRO/FRO.

10. A foreign student is required to register with FRRO/ FRO within 14 days of his/ her enrollment in the university/ institute. Online registration forms and other instructions are available at our website <a href="www.indianfrro.gov.in/frro">www.indianfrro.gov.in/frro</a> and
