No. GH/SH/35/2022/PVS/102020/474/S:- In exercise of the powers conferred by sub-section (1) of section 20 read with section 4 of the Gujarat Professional Technical Educational Colleges or Institutions (Regulation of Admission and Fixation of Fees) Act. 2007 (Guj. 2 of 2008), the Government of Gujarat hereby makes the following rules further to amend the Bachelor of Architecture, Bachelor of Construction Technology, Bachelor of Interior Design and Bachelor of Architecture and Interior Design Courses (Regulation of Admission and Payment of Fees) Rules, 2020, namely:-

- 1. (1) These rules may be called the Bachelor of Architecture, Bachelor of Construction Technology, Bachelor of Interior Design and Bachelor of Architecture and Interior Design Courses (Regulation of Admission and Payment of Fees) (Amendment) Rules, 2022.
- (2) They shall come into force on the date of their publication in the *Official Gazette*.
- 2. In the Bachelor of Architecture, Bachelor of Construction Technology, Bachelor of Interior Design and Bachelor of Architecture and Interior Design Courses (Regulation of Admission and Payment of Fees) Rules, 2020, for rule 20, the following rule shall be substituted, namely:-

## "20. Vacant seats.-

- (1) (a) For the Bachelor of Architecture, Bachelor of Interior Design and Bachelor of Architecture and Interior Design Courses, the vacant seats of Government and aided Colleges /Institutions shall be filled by the Admission Committee through online/offline counselling with following orders, namely:-
  - (i) the names of the candidates whose names appear in the merit list of the Admission Committee;
  - (ii) after allotting the seats to candidates mentioned in sub-clause (i) above, if any seat remains vacant, the Admission Committee shall fill such seats by inviting the application from the candidates who have cleared the qualifying examination with minimum eligibility criteria prescribed

in rule 5 and cleared NATA examination of corresponding year but have not registered in current year online/offline admission process. The merit list shall be prepared on the basis of the prevailing rule and guideline of Admission Committee.

- (iii) after allotting the seats to the candidates mentioned in sub-clauses (i) and (ii) above, if seats remain vacant, the Admission Committee shall fill such seats by inviting the application from the candidates who have cleared the qualifying examination with minimum eligibility criteria prescribed in rule 5 in supplementary examination and cleared NATA examination of corresponding year. The merit list shall be prepared on the basis of the prevailing rule and guideline of Admission Committee.
- (iv) after allotting the seats to the candidates mentioned in sub-clauses (i), (ii) and (iii) above, if seats remain vacant, the Admission Committee shall fill such seats by inviting the application from the candidates who have cleared the qualifying examination with minimum eligibility criteria prescribed in rule 5 and who have passed the qualifying examination from outside the Gujarat State and have cleared NATA examination conducted in the corresponding academic year, giving priority to the candidates of Gujarat origin. The merit list shall be prepared on the basis of the prevailing rule and guideline of Admission Committee.
- (b) For the Bachelor of Construction Technology Courses, the vacant seats of Government and aided Colleges /Institutions shall be filled by the Admission Committee through online/offline counseling with following orders, namely:
  - (i) the names of the candidates whose names appear in the merit list of the Admission Committee;
  - (ii) after allotting the seats to the candidates mentioned in sub-clauses (i) above, if seats remain vacant, the Admission Committee shall fill such seats by inviting the application from the candidates who have cleared the qualifying examination with minimum eligibility criteria prescribed in rule 5 and appeared in JEE (Main) examination of the corresponding year but have not registered in the current year online/offline admission process. The merit list shall be prepared on the basis of the prevailing rule and guideline of Admission Committee.
  - (iii) after allotting the seats to the candidates mentioned in sub-clauses (i)

and (ii) above, if seats remain vacant, the Admission Committee shall fill such seats by inviting the application from the candidates who have cleared the qualifying examination with minimum eligibility criteria prescribed in rule 5 in supplementary examination and shall have appeared in JEE (Main) examination of corresponding year. The merit list shall be prepared on the basis of the prevailing rule and guideline of Admission Committee.

- (iv) after allotting the seats to the candidates mentioned in sub-clauses (i)

  (ii) and (iii) above, if seats remain vacant, the Admission Committee shall fill such seats by inviting the application from the candidates who have cleared the qualifying examination with minimum eligibility criteria prescribed in rule 5 and who have passed the qualifying examination from outside the Gujarat State and have appeared in JEE (Main) conducted in the corresponding academic year, giving priority to the candidates of Gujarat origin. The merit list shall be prepared on the basis of the prevailing rule and guideline of Admission Committee.
- (v) after allotting the seats to candidates mentioned in sub-clauses (i), (ii), (iii) and (iv) above, if seats remain vacant, the Admission Committee shall fill such seats by inviting the application from the candidates who have cleared the qualifying examination from India (Including Gujarat) with minimum eligibility criteria prescribed in rule 5 but not appeared in JEE (Main) or any entrance examination, shall be eligible for admission. The merit list shall be prepared on the basis of aggregate percentage of marks obtained in qualifying examination".
- (2) After offering admission to all the candidates whose names appear in the merit list or after completion of the online admission process, if the seats remain vacant, such vacant seats shall be filled by the un-aided college or institution as Management Seat. Such vacant seats shall be filled by the college or institution by inviting application from the eligible candidates and preparing common inter-se merit-list.

The Admission Committee shall, by an advertisement in the prominent newspapers widely circulated in the State, by website and by such other means, as it may consider convenient, display the details of vacant seats and Schedule for vacant seats admission. The candidates who are already having the merit number of the Admission Committee shall have to submit copy of

his registration form to participate for the vacant seats round. Whereas, the eligible candidates who have not registered earlier shall have to apply at institute level as per Schedule declared by the Admission Committee.

All eligible/meritorious candidates shall have to approach to self-financed institutes of his choice for admission in vacant seats. An acknowledgement shall be given to the candidate by the concerned self-financed institutions. The concerned self-financed institutions shall process the filling up of vacant seats among such eligible / meritorious candidates who have submitted registration form by preparing common intra-se merit list in the following order and guidelines issued by the Admission Committee from time to time:

- (a) For the Bachelor of Architecture, Bachelor of Interior Design and Bachelor of Architecture and Interior Design Courses, the vacant seats of un-aided Colleges /Institutions shall be filled by the Admission Committee through online/offline counseling with following orders, namely:-
  - (i) the names of the candidates whose names appear in the merit list of the Admission Committee;
  - (ii) after allotting the seats to candidates mentioned in sub-clause (i) above, if any seat remains vacant, the Admission Committee shall fill such seats by inviting the application from the candidates who have cleared the qualifying examination with minimum eligibility criteria prescribed in rule 5 and cleared NATA examination of the corresponding year but have not registered in current year online/offline admission process. The merit list shall be prepared on the basis of the prevailing rule and guideline of Admission Committee;
  - (iii) after allotting the seats to the candidates mentioned in sub-clauses (i) and (ii) above, if seats remain vacant, the Admission Committee shall fill such seats by inviting the application from the candidates who have cleared the qualifying examination with minimum eligibility criteria prescribed in rule 5 in supplementary examination and shall have cleared NATA examination of the corresponding year. The merit list shall be prepared on the basis of the prevailing

rule and guideline of Admission Committee;

- (iv) after allotting the seats to the candidates mentioned in sub-clauses (i), (ii) and (iii) above, if seats remain vacant, the Admission Committee shall fill such seats by inviting the application from the candidates who have cleared the qualifying examination with minimum eligibility criteria prescribed in rule 5 and who have passed the qualifying examination from outside the Gujarat State and have cleared NATA examination conducted in the corresponding academic year, giving priority to the candidates of Gujarat origin. The merit list shall be prepared on the basis of the prevailing rule and guideline of Admission Committee;
- (b) For the Bachelor of Construction Technology Courses, the vacant seats of un-aided Colleges /Institutions shall be fill by the Admission Committee through online/offline counseling with following orders, namely:-
  - (i) the names of the candidates whose names appear in the merit list of the Admission Committee:
  - (ii) after allotting the seats to the candidates mentioned in sub-clause (i) above, if seats remain vacant, the Admission Committee shall fill such seats by inviting the application from the candidates who have cleared the qualifying examination with minimum eligibility criteria prescribed in rule 5 and appeared in JEE (Main) examination of the corresponding year but have not registered in the current year online/offline admission process. The merit list shall be prepared on the basis of the prevailing rule and guideline of Admission Committee;
  - (iii) after allotting the seats to the candidates mentioned in sub-clauses
    (i) and (ii) above, if seats remain vacant, the Admission Committee
    shall fill such seats by inviting the application from the candidates
    who have cleared the qualifying examination with minimum
    eligibility criteria prescribed in rule 5 in supplementary
    examination and shall have appeared in JEE (Main) examination of
    corresponding year. The merit list shall be prepared on the basis of
    the prevailing rule and guideline of Admission Committee;

- (iv) after allotting the seats to the candidates mentioned in sub-clauses (i), (ii) and (iii) above, if seats remain vacant, the Admission Committee shall fill such seats by inviting the application from the candidates who have cleared the qualifying examination with minimum eligibility criteria prescribed in rule 5 and who have passed the qualifying examination from outside the Gujarat State and have appeared in JEE (Main) conducted in the corresponding academic year, giving priority to the candidates of Gujarat origin. The merit list shall be prepared on the basis of the prevailing rule and guideline of Admission Committee;
- (v) after allotting the seats to candidates mentioned in sub-clauses (i),
  (ii), (iii) and (iv) above, if seats remain vacant, the Admission
  Committee shall fill such seats by inviting the application from the candidates who have cleared the qualifying examination from India (Including Gujarat) with minimum eligibility criteria prescribed in rule 5 but not appeared in JEE (Main) or any entrance examination, shall be eligible for admission. The merit list shall be prepared on the basis of aggregate percentage of marks obtained in qualifying examination".
