### **Admission on Vacant Seats after Two Online Rounds of MBA/MCA courses at Self Finance Institutions for Academic Year 2022-23**

The Vacant seats in Self Finance Institutes (SFI) shall be filled as per provisions of Rule-18 of prevailing notification for admission. Accordingly aspiring candidates fulfilling eligibility criteria of notification for admission to MBA/MCA courses dated 24.06.2020 & 23.06.2020 respectively issued by Education department, Government of Gujarat shall have to contact the concerned self-finance institute of his/her choice between **13.10.2022 to 25.10.2022** as per the counseling schedule declared by the respective institute for vacant seats admission process at the institute of his/her choice and preference. The candidate has to submit his/her application with all requisite documents and an application fee of Rs.350/- (Only from those who are not in merit of ACPC) at the concerned institution within the prescribed time limit.

The concerned self-finance institute shall process the filling up of vacant seats among such eligible candidates in accordance with all provisions of prevailing notifications of Government of Gujarat for admission to MBA/MCA courses. The Merit list will be based on the following priority (i) registered candidates having merit rank given by ACPC of 2022, (ii) not registered for ACPC counseling but appeared for CMAT 2022 based on obtained CMAT marks/score and (iii) all eligible aspiring candidates who have passed the qualifying Graduation exam with minimum eligibility criteria as prescribed in rule 5 of prevailing admission notification, but have neither qualified CMAT for the current year.

The details of vacant seats, its guidelines and procedure for filling in SFI institutes at institute level are available on committee's website.

In case of admission to SFI in vacant seats at institute level, the process for refund of fee for seat already allotted by this committee shall be as per Rule-17 of prevailing notifications of Government of Gujarat for admission to MBA/MCA courses.
