Notice for Aspiring Candidates

Admission to Vacant Seats due to non allotment after Online Admission Process in MBA|MCA Courses in Government/Grant-In-Aid Institutes for Academic Year 2022-23

For admission on vacant seats due to non allotment in Government & Grant-in-aid Institutes the admission and preparation of merit list shall be done in following order, (i) registered candidates having merit rank given by ACPC of 2022, (ii) not registered for ACPC counselling but appeared for CMAT 2022 based on obtained marks/score in CMAT 2022 and (iii) all eligible aspiring candidates who have passed the qualifying Graduation exam with minimum eligibility criteria as prescribed in rule 5 of prevailing admission notification, but have neither qualified CMAT for the current year and if they are willing to secure admission to non-allotted vacant seats arising after online admission process of MBA-MCA program in Government/Grant-In-aid institutes for academic year 2022-23 are hereby informed to visit the committee's website jacpcldce.ac.in for further details. ***The common merit list shall be prepared on the following mentioned priority:***

- (i) the admission committee shall fill such seats by the names of the candidates whose name appear in the merit list of the Admission Committee who have cleared the qualifying examination with minimum eligibility criteria prescribed in rule 5 and shall have appeared in Common Management Aptitude Test (CMAT) as prescribed by AICTE, for the corresponding year. The merit list shall be prepared on the basis of the marks obtained in CMAT of the corresponding year. The immediate round shall be conducted for such candidate exclusively.
- (ii) after allotting the seats to candidates mentioned in clause (i), if seats remain vacant, the Admission Committee shall fill such seats by inviting the application from the candidates who have cleared the qualifying examination with minimum eligibility criteria prescribed in rule 5 and shall have appeared in Common Management Aptitude Test (CMAT) as prescribed by AICTE for the corresponding year but have not appeared in current year online admission process. The merit list shall be prepared on the basis of the marks obtained in CMAT of the corresponding year.
- (iii) after allotting the seats to candidates mentioned in clauses (i) and (ii) if seats remain vacant, the Admission Committee shall fill such seats by inviting the application from the candidates who have cleared the qualifying examination with minimum eligibility criteria prescribed in rule 5 but not appeared in Common Management Aptitude Test (CMAT) as prescribed by AICTE for the corresponding year shall be eligible for admission. The merit list of such candidates shall be prepared on the basis of percentage of marks obtained at qualifying examination.

1. Candidates fulfilling eligibility criteria as mentioned in rule 5 pursuant to above mentioned modalities for admission to MBA|MCA courses shall have to fill the Google form available on the link <https://forms.gle/ufybqyU533tYBWFg7> between 14/10/2022 to 16/10/2022 (5.00PM) to become eligible for participation in this round.

The candidate has also to fill the application form available as Annexure-I of this document and bring the duly filled form along with self-attested copies of documents and original copies of the same (In case of Internet copy of result it shall be duly signed and stamped by University/Institute) as mentioned in the application form at the time of counselling personally at ACPC, Ahmedabad.
3. The candidates shall have to bring a Demand Draft for ₹ 350/- towards nonrefundable fee for registration at the time of counselling along with the above mentioned application form and copies of requisite documents at the time of counselling personally at ACPC, Ahmedabad. The DD should be payable in favor of "ACPC-GTERS" and payable at Ahmedabad.
4. Please mention your name and discipline applying for on the reverse side of demand draft.
5. The detailed discipline wise counselling schedule and merit list shall be uploaded on committee's website jacpcldce.ac.in tentatively on 17.10.2022 (After 05:00 PM).
6. Since this admission procedure is on vacant seats as per modality described above, the merit list of candidates who have cleared qualifying exam with minimum eligibility criteria as prescribed in rule 5 but have not qualified CMAT 2022 shall be prepared on the basis of percentage of marks obtained at qualifying examination, giving priority to candidates having ACPC merit and CMAT 2022 appeared candidates.
7. There is no other means of registering/applying for the candidature for this round of admission on vacant seats, thus candidates who fail to fill the Google form as stated above within prescribed time limit shall not be allowed to participate in this round of admission.
8. The candidates are advised to read carefully important instructions/guidelines before applying and filling the Google form (All available on committee's website). However in case of a candidate applying without being eligible, or incomplete form filling his/her application will be summarily rejected and his application fee will be forfeited. No correspondence will be entertained in this matter.
9. The details of vacant seats are as stated above, the Eligibility criteria, Notifications for admission to MBA|MCA courses and other relevant details are available on committee's website.
10. The admission shall be subject to availability of Seats in the concerned course and institute at the time of counselling subject to fulfilling of all eligibility requirements as per prevailing admission rules of Govt. of Gujarat for MBA|MCA Courses.
11. It is to be noted that the above said procedure of admission is applicable only to vacant seats after online admission process for MBA|MCA courses in Government/Grant-in-aid institutes (as stated above).
12. The candidates who are in merit list of ACPC can also participate in the above stated vacant seat admission process.
