

Instructions/Steps to be followed for Admission to Vacant seats in B.Arch. course in Grant-in-aid institutes for academic year 2022-23.

In concurrence to the advertisement uploaded by this committee regarding modalities for vacant seats admission process. The detail process for participating in admission to vacant seats in Grant-in- Aid (GIA) institutes is as follows. Candidates who are willing to secure admission to vacant seats arising after online admission process of B.Arch program at Grant-In-aid institutes for academic year 2022-23 are hereby informed to follow procedure as per following instructions and timeline.

Broad tentative timeline

Steps/Instructions of Participation in above stated admission process

- 1. The candidates who are in merit list of ACPC and are willing to take part in vacant seats in GIA shall have to give online consent from their login ID on website https://gujacpc.nic.in between 17-10-2022 and 18-10-2022. The candidate has to login to his account at https://gujacpc.nic.in and Click here to Proceed link available at the dashboard, the candidate will be diverted to Consent screen, here the candidate has to give his consent as YES or NO by clicking Yes, the candidate will be able to participate in the referred Round of admission. After giving consent, the candidate has to proceed for choice filling in their login ID between 17-10-2022 and 18-10-2022. It is compulsory to give consent and fill choices again, to become eligible for this round of vacant seats in GIA institutes. The consent once given cannot be changed later on, which may please be noted. If you have given consent as NO, in such case you will not be able to participate in Round for vacant seats in GIA institutes.
- 2. Candidates fulfilling eligibility criteria as mentioned in rule 5 of admission notification for B.Arch. course who have not registered in online B.Arch. admission process of ACPC shall have to do new online registration by filling online registration form, uploading necessary documents and paying Rs. 300/- registration fees online from

committee's website <u>www.jacpcldce.ac.in</u> and <u>www.gujacpc.ac.in</u> by clicking on **ONLINE REGISTRATION LINK** between **13/10/2022 to 14/10/2022** to become eligible for participation in this round.

- 3. For participating in Round for vacant seats in GIA institutes, it is compulsory for the candidates who are in merit list of ACPC and given consent and Newly Registered Candidates to do the fresh choice filling between 17-10-2022 and 18-10-2022 for the said round.
- 4. The merit list shall be declared on committee's website <u>jacpcldce.ac.in</u> tentatively on **16.10.2022**.
- 5. Since this admission procedure is on vacant seats as per prevailing rule 20 (1) (ii) of the admission notification, Merit list will be prepared on following sequence:
 - (1) Candidates whose names appear in the merit list of the admission committee.
 - (2) Candidates who cleared qualifying examination with minimum eligibility criteria as per rule -5 and cleared NATA examination of corresponding year but have not registered in current admission process of ACPC.
 - (3) Candidates who cleared qualifying examination with minimum eligibility criteria in supplementary examination as per rule -5 and cleared NATA examination of corresponding year.
 - (4) Candidates who cleared the qualifying examination with minimum eligibility criteria as per rule-5 from outside Gujarat and cleared NATA examination of corresponding year, giving priority to the candidates of Gujarat origin.
 - (5) Candidates who cleared qualifying examination with minimum eligibility criteria as per rule-5 and appear in aptitude test in architecture conducted by NTA (i.e. JEE) (It is applicable for current academic year only).
- 6. There is no other means of registering/applying for the candidature for this round of admission on vacant seats, thus candidates who do not give online consent and/or not fill choices/fail to do registration as stated above within prescribed time limit shall not be allowed to participate in this round of admission.
- 7. The candidates are advised to read carefully important instructions/guidelines before applying and filling online registration form (All available on committee's website). However in case of a candidate applying without being eligible or incomplete registration, his/her application will be summarily rejected and his/her application fee will be forfeited. No correspondence will be entertained in this matter
- 8. The details of vacant seats are as stated above, the Eligibility criteria, Notifications for admission to B.Arch. course and other relevant details are available on committee's website www.jacpcldce.ac.in.
- 9. The admission shall be subject to availability of Seats in the concerned course and institute at the time of counseling subject to fulfilling of all eligibility requirements as per prevailing admission rules of Govt. of Gujarat for B.Arch Course.
- 10. It is to be noted that the above said procedure of admission is <u>applicable only to</u> vacant seats after online admission process for B. Arch. course in Grant-in-aid institutes (as stated above).
- 11. The candidates are advised to visit the committee's website www.jacpcldce.ac.in on regular basis for latest updates including notices/rules/circulars/guidelines etc. all related to admission process. The candidates can also call helpline No. **07926566000** for any queries.
