### Instructions/Notes:

- (1) No separate call letters shall be issued for appearing in counseling. The candidate shall have to remain present as per above mentioned schedule at his own cost. It is mandatory to remain present personally as per above schedule for allocation of seat.
- (2) Candidates who have passed the qualifying examination i.e. B.E. / B.Tech. with minimum 50% (45% for SC/ST/SEBC candidates) at the qualifying examination as per eligibility criteria mentioned in the prevailing admission rules, and have filled the Google form within prescribed time limit shall only be eligible for the Counseling / admission process. They shall have to produce original Degree certificate/Provisional degree certificate and mark sheet of final year at the time of counseling. The candidates failing to do so their candidature shall not be considered for counseling process.
- (3) The candidate has also to fill the application form available as Annexure-I as available at the end of this document and bring the duly filled form along with self-attested copies of documents as mentioned in the application form at the time of counselling personally at ACPC, Ahmedabad.
- (4) The candidates shall have to bring a Demand Draft for **Rs. 500/-** towards non-refundable fee for registration at the time of counselling along with the above mentioned application form and copies of requisite documents at the time of counselling personally at ACPC, Ahmedabad. The DD should be payable in favour of "**ACPC-GTERS**" and payable at Ahmedabad.
- (5) Please mention your name and discipline applying for on the reverse side of demand draft.
- (6) Since this admission procedure is on vacant seats as per prevailing rule 20 (1) (ii) of the admission notification, the merit list of candidates who have cleared qualifying exam with minimum eligibility criteria

as prescribed in rule 5 but have neither qualified GATE nor appeared in Common Entrance Test (PGCET) conducted by ACPC shall be prepared on the basis of percentage of marks obtained at qualifying examination, giving priority to candidates having ACPC merit OR GATE qualified.

- (7) There is no other means of registering/applying for the candidature for this round of admission on vacant seats, **thus candidates who have not filled the Google form within prescribed time limit shall not be allowed to participate in this round of admission.**
- (8) The candidate who secures admission shall have to report to the admitting institute within three working days and shall have to pay the entire semester fee at the admitting institute
- (9) The candidates shall have to bring all original certificates/testimonials/documents for verification at the time of counseling failing to do so they shall not be allowed for the counseling/admission process.
- (10) However in case of a candidate applying without being eligible, or incomplete form filling, his/her application is summarily rejected and his application fee will be forfeited. No correspondence will be entertained in this matter.
- (11) The admission shall be subject to availability of Seats in the concerned course and institute at the time of counselling subject to fulfilling of all eligibility requirements as per prevailing admission rules of Govt. of Gujarat for M.E./M.Tech Courses.
- (12) It is to be noted that the above said procedure of admission is **applicable only to vacant seats arising due to Non-allotment of seats after online admission process for M.E./M.Tech. courses in Government/Grant-in-aid/Govt. Autonomous institutes (as stated above).**
- (13) It is the responsibility of the admitting institute/university to award the MHRD/AICTE Post Graduate scholarship/assistantship to only those candidates who have secured marks equal to or more than the “qualifying marks” in the concerned GATE discipline and for the corresponding category of the candidate as per the provisions of prevailing guidelines/norms of AICTE. The management of such postgraduate scholarship/assistantship is also the responsibility of the admitting institution/university. The admission committee (ACPC) has no role in the award or disbursement of any such scholarship/assistantship. Thus, candidates must note that mere admission as “GATE qualified candidates”, does not guarantee MHRD/AICTE Scholarship/Assistantship.
- (14) The Candidates are hereby informed to verify/ascertain the nomenclature of degree awarded by concerned Institute/University/affiliating university, its syllabus etc. for their allotted course before the finalization of the admission by them, since the admission committee (ACPC) has no role in deciding the nomenclature of degree awarded by concerned Institute/university.
